INSTRUCTIONS TO THE VOTER

1. TO VOTE YOU MUST BLACKEN THE OVAL () COMPLETELY. Do not make an X or .

2. TO WRITE-IN A NAME - YOU MUST blacken the oval () and write in the name on the line provided.

3. USE ONLY THE PENS PROVIDED. Your ballot will be counted by an optical scanner and if you use any other type of pen or pencil it may not be counted.

4. AFTER VOTING - Insert ballot in ballot envelope so that the judges stamp appears at the bottom. DO NOT FOLD THE BALLOT.

HOME RULE CHARTER AMENDMENT

Shall Article 4(F) of the Home Rule Charter of the City of Fargo be amended to provide that initiated or referred ordinances approved by a vote of the voters may only be repealed or amended by a vote of the voters, all as provided in the Notice of Proposed Home Rule Charter Amendment as published in The Forum on the 26th day of May, 2008?

Currently, Article 4(F) of the Home Rule Charter of the City of Fargo provides that an initiated or referred ordinance approved by the voters may be repealed or amended by a two-thirds majority of the city commissioners within one year of the effective date of the initiated or referred ordinance and by simple majority thereafter.
